RESOLUTION NO. 009 OF THE YEAR 2015

At 8:07 PM Councilman Morris Riddell Jr. offered the following resolution and moved its adoption:

In the Matter of the Adoption of Local Law No. 001 of the Year 2015 entitled "Appointment of Alternate Members to the Town of Harpersfield Planning Board".

WHEREAS, the Town Board has reviewed and considered the proposed Local Law No. 001 of the Year 2015;

WHEREAS, the Local Law was presented to the Town Board at least 10 days prior to the Town Board meeting on June 9, 2015;

WHEREAS, the Town Board adopted Resolution No. 008 of the Year 2015 on June 9, 2015 scheduling a public hearing on the proposed Local Law No. 001 of the Year 2015;

WHEREAS, the public hearing was properly noticed in the Town's official newspaper on June 17, 2015;

WHEREAS, the public hearing on the proposed Local Law was held on July 14, 2015 at the Town Hall;

WHEREAS, the Town Board reviewed and considered all public comments received on the proposed Local Law;

WHEREAS, the proposed Local Law was on file for inspection at the Town Clerk's office prior to the hearing and during the public review process;

WHEREAS, the proposed Local Law serves to strengthen and protect the Town's public safety, health and welfare;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS BY THE TOWN BOARD OF THE TOWN OF HARPERSFIELD, DELAWARE COUNTY, NEW YORK:

THAT THE Town Board of the Town of Harpersfield hereby determines that proposed Local Law No. 001 of the Year 2015, attached hereto and made a part hereof, is hereby adopted as a Local Law entitled "Appointment of Alternate Members to the Town of Harpersfield Planning Board"; and

IT IS FURTHER RESOLVED, that the Town Clerk and the Attorney for the Town are hereby directed to take such actions as are necessary to implement this resolution and effect adoption of the Local Law.
