RESOLUTION NO. 023 FOR THE YEAR 2016

Councilman Edward S. Slicer offered the following resolution and moved its adoption:

RESOLUTION OF THE TOWN BOARD OF THE TOWN OF HARPERSFIELD IN THE MATTER OF THE ADOPTION OF LOCAL LAW NO. 002 OF THE YEAR 2016 ENTITLED "LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW § 3-c.

WHEREAS, in accordance with subdivision 5 of the General Municipal Law § 3-c of the State of New York which provides municipalities with the express authorization to override the tax levy limit established in General Municipal Law § 3-c by passing a Local Law approved by a vote of at least sixty percent (60%) of the Town Board; and

WHEREAS, the proposed Local Law was presented to the Town Board at least eleven days (11) prior to the Town Board meeting held on November 9, 2016; and

WHEREAS, the Town Board adopted a resolution on October 11, 2016, scheduling a public hearing on the proposed Local Law No. 002 Of The Year 2016; and

WHEREAS, the public hearing on the proposed Local Law was held on November 9, 2016, at the Town Hall located at 25399 State Hwy 23, Harpersfield, Delaware County, New York; and

WHEREAS, the Town Board reviewed and considered all public comments received on the proposed Local Law; and

WHEREAS, the proposed Local Law was on file for inspection at the Town Clerk's office prior to the hearing and during the public review process; and

WHEREAS, the Town Board has issued a negative declaration under SEQRA for the proposed Local Law No. 002 Of The Year 2016 thereby complying with the mandates of the State Environmental Quality Review Act; and

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS BY THE TOWN BOARD OF THE TOWN OF HARPERSFIELD, DELAWARE COUNTY, NEW YORK:

The Town of Harpersfield Local Law to Override the Tax Levy Limit Established in General Municipal Law § 3-c, being Local Law No. 002 Of The Year 2016, is hereby adopted and the Town Clerk is hereby directed to file said Local Law with the Office of the Secretary of State in accordance with State Law.
