RESOLUTION NO. 022 OF THE YEAR 2024.

Councilmember Patrick F. Funk offered the following resolution and moved its adoption:

TITLE: RESOLUTION OF THE HARPERSFIELD TOWN BOARD ACCEPTING A PROPOSED LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW § 3-c AND SCHEDULING A PUBLIC HEARING FOR SAME.

WHEREAS, on June 24, 2011 the New York State Legislature enacted Chapter 97 of the NYS Laws of 2011, hereinafter referred to as the "General Municipal Law § 3-c"; and

WHEREAS, General Municipal Law § 3-c expressly authorizes local governments to override the tax levy limit by the adoption of a local law approved by a vote of at least sixty percent (60%) of the total voting power of the governing body (in this case, the Harpersfield Town Board"); and

WHEREAS, the Town's Attorney has prepared a proposed Local Law to Override the Tax Levy Limit Established in General Municipal Law § 3-c; and

WHEREAS, the Town Board has reviewed and modified the proposed Local Law to Override the Tax Levy Limit Established in General Municipal Law § 3-c; and

NOW, THEREFORE, BE IT RESOLVED, that the Town Board shall hold a public hearing for consideration of the Local Law to Override the Tax Levy Limit Established in General Municipal Law § 3-c on November 13, 2024 at 7:00 PM at the Town Hall; and

BE IT FURTHER RESOLVED, that the Town Clerk is hereby authorized and directed to publish notice of said hearing in The Daily Star, and to post copies of such notice in the manner provided by law.
