RESOLUTION NO. 010 OF THE YEAR 2016

Councilman Harry Peterson offered the following resolution and moved its adoption:

In the Matter of the Adoption of Local Law No. 001 of the Year 2016 entitled "Local Law Amending Local Law No. 001 Of The Year 2012, Section 3.2 In Its Entirety";

WHEREAS, the Town Board of the Town of Harpersfield, New York (the "Town") deems it advisable to maintain its eligibility to participate in the National Flood Insurance Program ("NFIP"); and

WHEREAS, new Flood Insurance Study and Flood Insurance Rate Maps updating the 100 year base flood elevations for the Town have been completed by the Federal Emergency Management Agency ("FEMA"); and

WHEREAS, to maintain eligibility in the NFIP it is necessary for the Town to adopt the new Flood Insurance Study and Flood Insurance Rate Maps into its flood plain management regulations; and

WHEREAS, the New York State Department of Environmental Conservation ("NYSDEC") has also instructed the Town Board to update its Flood Plain Local Law to conform to the current rules and regulations required by FEMA; and

WHEREAS, the Town Board deems it advisable to adopt a local law that amends Local Law No. 001 Of The Year 2012 of the Town of Harpersfield entitled "Flood Damage Prevention Local Law" to adopt the new maps and to incorporate the current FEMA regulations regarding flood plain management; and

WHEREAS, the proposed Local Law was presented to the Town Board at least 10 days prior to the Town Board meeting on April 12, 2016; and

WHEREAS, the Town Board adopted a resolution on March 8, 2016 scheduling a public hearing on the proposed Local Law for April 12, 2016; and

WHEREAS, the public hearing on the proposed Local Law was held on April 12, 2016 at the Town Hall; and

WHEREAS, the Town Board reviewed and considered all public comment received on the proposed Local Law; and

WHEREAS, the proposed Local Law was on file for inspection at the Town Clerk's office prior to the hearing and during the public review process; and NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS BY THE TOWN BOARD OF THE TOWN OF HARPERSFIELD, DELAWARE COUNTY, NEW YORK:
